COMMISSION RESOLUTION NO. 2017-0

APPROVING THE RENEWAL OF APPOINTMENTS OF MEMBERS OF THE NATIONAL PANEL OF TECHNICAL EXPERTS (NPTE)

WHEREAS, climate change remains to be one of the greatest global challenges of our time and impacts our country's economic, environmental and social well-being, compromising our ability to pursue sustainable development;

WHEREAS, the Philippines, a member of the United Nations Framework Convention on Climate Change (UNFCCC), enacted Republic Act No. 9729, the Climate Change Act of 2009, amended by R.A. 10174, to afford full protection and the advancement of the right of the people to a healthful ecology in accord with the rhythm and harmony of nature";

WHEREAS, the Philippine National Framework Strategy on Climate Change, provides "as mean global temperature rises and climate change impacts intensify, the Philippines—like the rest of the world—will encounter growing stresses in food production, health, and economic security";

WHEREAS, the climate change challenge involves diverse technical issues that require multi-disciplinary, cross-sectoral, and science-based expertise on climate change mitigation and adaption, and our country is privileged to have homegrown experts on said areas;

WHEREAS, mindful of the necessity to improve the scientific understanding of climate change, the Commission constituted the first National Panel of Technical Experts (NPTE) in accordance with the Climate Change Act of 2009, as amended, in order to develop and adopt a national strategic framework that is risk-based:

WHEREAS, the qualifications of the members of the first NPTE selected are based on Section 10 of the Guidelines for the Operationalization of the National Panel of Technical Experts in the following fields of study:
